<sup>2</sup> Bespoke Standing Instruction Service - all social security payments (rather than a pre-agreed fixed amount) whenever (instead of a pre-agreed fixed date) they were credited by the Social Welfare Department to the recipient/appointee's bank account in Hong Kong will automatically be remitted to the designated Mainland bank account.  
<sup>3</sup> 專設常行指示服務 - 由社會福利署向計劃受惠人/受委人發放的援助金或津貼，將由受惠人/受委人的香港銀行戶口自動全額匯至指定的內地銀行戶口。計劃受惠人/受委人無須預設固定金額或指定日期。
